## Brookline College Education Alliance Memorandum of Understanding

This Education Alliance Memorandum of Understanding ("MOU") is between Brookline College ("Brookline") and \_\_\_\_\_ (hereinafter "MEMBER"). Through this MOU, Brookline offers a tuition reduction on all of Brookline's campus and online programs to eligible employees. MEMBER will provide Brookline access to appropriate sessions, education fairs and direct marketing to MEMBER employees, as approved by MEMBER.

### Benefits Offered by Brookline

1. Brookline will provide a twenty percent (20%) tuition reduction to MEMBER employees who meet Brookline's admission standards and enroll in a diploma, certificate or degree program at Brookline. After the effective date of this MOU and after the date the student identifies as an employee of MEMBER, reduced tuition will apply to the then current rates at the time the student enrolls in a course. The reduced tuition does not apply to fees (e.g. technology fees for online students). In the event that a MEMBER employee was enrolled at Brookline prior to the effective date of this MOU, the reduced tuition shall not be retroactive. All students are subject to Brookline's student policies.
2. Brookline will provide MEMBER and MEMBER's employees with information about Brookline's diploma, certificate and degree programs to support MEMBER's internal promotion of continuing education.

### MEMBER Contributions

1. MEMBER will work with Brookline to communicate the benefits of this MOU and the many educational opportunities available at Brookline.
2. MEMBER employees will furnish proof of employment in the form of a W2 or 1099 or paystub at the time of enrolling in a Brookline diploma, certificate or degree program.

### General Terms and Conditions

1. This MOU becomes effective on the date both parties have signed the MOU. Either party may terminate this MOU at will upon thirty (30) days prior written notice.
2. Brookline may use MEMBER name verbally for reference purposes only. MEMBER grants Brookline the right to use MEMBER name and logo in writing for purposes of this MOU only.
3. Each party acknowledges that the relationship with the other is that of an independent contractor.
4. Each party agrees to abide by all applicable Federal and State Laws.
5. This MOU does not create any rights, title, or interest for any entity other than Brookline and MEMBER.
