

CARES Act Student Grant Distribution Methodology

- Total Eligible Students: 1,628 All campus based students who have a FAFSA on file and were in attendance as of April 26, 2020
- 386 students did not receive Pell
- Seven Categories of Pell Recipients:
 - Category 1
 - Less than \$1k Pell recipient 14 students
 - Category 2
 - More than \$1k, less than \$2k Pell recipient 42 students
 - Category 3
 - More than \$2k, less than \$3k Pell recipient 110 students
 - o Category 4
 - More than \$3k, less than \$4k Pell recipient 98 students
 - Category 5
 - More than \$4k, less than \$5k Pell recipient 94 students
 - Category 6
 - More than \$5k, less than \$6k Pell recipient 354 students
 - Category 7
 - More than \$6k Pell recipient- 530 students
- There are 7 types of program lengths
 - 7 Months Most Diploma Programs
 - o 8 Months Associate of Science in Allied Health
 - o 9 Months Dental Assisting and Sterile Processing Diploma
 - 16 Months All other Associate Degree programs
 - 20 Months Physical Therapist Assistant
 - 24 Months Surgical Technologist
 - 32 Months All Bachelor Degree programs
- Awarding Methodology:
 - Using the 7 month diploma programs as the baseline, a multiplier was applied to each additional program length based on how much longer the program is then the baseline
 - A chart was then created and the baseline grant amounts adjusted to fit the total allocation
